Introduction

The **Integrated Action Plan (IAP)** of Igoumenitsa is a practical document focusing on concrete actions and its main aim is to help city officials, policy makers and communication specialists, to plan and implement engagement activities in focus areas.

The successful implementation of **IAP** should help City Administration of Igoumenitsa to achieve the following long-term goals and objectives in the focus area and the city in general:

- More people are participating in decision-making process and governance of city
- The decisions made are of better quality and better understood by citizens
- Better cooperation with key stakeholders leads to new innovative co-creation models and tools

This IAP is being developed in the framework of URBACT Action Planning Network THRIVING STREETS. URBACT Action Planning Networks improve sustainable local policies through integrated action planning and an organized process of exchange and learning among cities across Europe. THRIVING STREETS is a Network aiming to build a case for sustainable mobility, unlocking suppressed demand for active mobility, while at the same time, enhancing resilience, quality of life and economic growth in the cities involved.

Taking into consideration that Mobility is at the crossroads of various urban policies in Europe, Thriving Streets is trying to connect mobility with economic prosperity, accessibility, inclusion, participation, and health to encourage a change towards more resilient and attractive cities. Thriving Streets project is co-financed by the European Regional Development Fund.

The city of Igoumenitsa is one of the partners of the ten-city-network, working together to improve sustainable mobility in urban areas from an economic and social perspective.

It is led by the **City of Parma** and includes nine partner cities:

- Antwerp (Belgium),
- Nova Gorica (Slovenia),
- Igoumenitsa (Greece),
- Santo Tirso (Portugal),
- **Oradea** (Romania),
- **Debrecen** (Hungary),

1. Context and Process

1.1. City Context

Igoumenitsa with a population of about 12.700 citizens is the capital of the Region of Thesprotia at the Northwest coast of Greece on the Ionian Sea. It is a strategic point for tourism and commerce in northern Greece. The Municipality of Igoumenitsa was established in 2011 ("Kallikratis" Programme) after merging the pre-existing municipalities of Igoumenitsa, Margariti, Parapotamos, Sivota and the Community of Perdika and has a population of 25,709 inhabitants (2021 census). It borders with the Municipalities of Filiates and the Municipalities of Souli, with which it constitutes the Region of Thesprotia, as well as in the wider area with the Municipalities of Parga, Paxos and Corfu.




The Municipality of Igoumenitsa, whose population has increased by 17.4% in the last decade according to the Hellenic Statistical Authority data, is emerging as the west gate of the country and a centre of development with a regional and transnational role.




The construction of the New Port which currently occupies the second place among the ports of the Greek Territory in passenger traffic has brought an end to the isolation of the area. It is the closest port to Italy with direct connections to Brindisi, Bari, Ancona and Venice. It provides Mooring Services to the liners, Transport Services to passengers and vehicles. A direct road network ("Ionian Road" & "Egnatia Road") connects the city to Athens (480km), with Thessaloniki (327km) and Ioannina (65km). Although Igoumenitsa is located in a geographically strategic point, it has not yet been developed as a touristic centre or as a "destination" point for visitors. The town lacks appropriate infrastructure that could promote the city as an attraction pole; however, the lack of mobility modes alternative to private car is a main weakness of the city. The main challenge of Igoumenitsa is how to become attractive for tourists, reduce the negative impacts of visitors and provide appealing alternatives to private vehicles mobility.

In the broader context, the region that Igoumenitsa is located, the Region of Epirus lies in NW Greece, between the Pindos Mountain range and the Ionian Sea. The Region of Epirus is one of the 13 regions of Greece. It is administratively a secondary governmental organization and is geographically identified with the homonymous department. It occupies an area of 9,203 sq. Km. and its population is 336,856, according to the latest NSSG inventory. Its untouched mountainous mass of Pindos with its great virgin forests, the Dragon Lakes (the mythical mountain lakes) and the untamed slopes provide a plethora of activities (mountaineering, climbing, ski, hiking, mountain biking etc.) in a scenery of singular beauty, as well as the rivers of Epirus which offer other activities such as kayak, rafting, canoeing etc. Arachthos especially, is considered as one of the most beautiful and challenging rivers for kayaking, while Voidomatis runs through the impressive gorge of Vikos.



The Regional Unit of (RU) Thesprotia, with a population of 46 000, is one of the more sparsely populated regional units of Greece. Thesprotia is one of the regional units of Greece. It is part of the Epirus region. Its capital and largest town is Igoumenitsa. Thesprotia is named after the Thesprotians, an ancient Greek tribe that inhabited the region in antiquity. The economy of the RU area is mostly based on livestock farming and agriculture; it mainly produces citrus fruits, corn, clover, rice and kiwis. The fact that Igoumenitsa has the largest north-western port in the country, in conjunction with the completion and operation of Egnatia Odos, render the RU an entrance point into Greece and a transit centre at European level. The RU of Thesprotia is also home to the Souli of history, the inhabitants of which are famous for their heroism before the start of the Greek War of Independence.



Economy


The Municipality of Igoumenitsa shows drastic changes in the structure of economic activity during the last 10-20 years. In general, the Municipality of Igoumenitsa does not present the typical characteristics of a rural regional municipality, where the majority of the inhabitants are engaged in the primary or secondary sector. The Municipality is differentiated from the typical Greek region, being an urban center with an emphasis on services. The tertiary sector is the dominant production sector and is more related to transport and tourism activities. The emergence of Igoumenitsa as the

western gateway of the country to Western Europe now gives high priority to Igoumenitsa as a development center with an inter-regional and transnational role, in parallel and complementary operation with Ioannina. Due to the geographical location of the Municipality, trade is significantly enhanced through the port of Igoumenitsa and the roads (Egnatia Odos and Ionia Odos). Tourism, despite the peculiarities of the region and the lack of high level infrastructure, is considered an important wealth-producing resource for the region. The tourism industry is constantly developing, being the great advantage for the development of the tertiary sector.

However, we should point out the fact that, as the recent health crisis has shown us, the high dependence on the tourism sector, but also on specific markets, leaves the areas that invest exclusively in them particularly exposed. The longer the epidemiological situation continues, the greater the risk that areas that are heavily dependent on their tourism industry will suffer greater and permanent damage, resulting in permanent job losses and the closure of some businesses. These risks can help to slow down their economic recovery even after the economies "open up".

Employment

According to the official data of Hellenic Statistic Authority, unemployment in the Region of Epirus, in the first quarter of 2020, increased to 17.5%, from 16.7% recorded in the fourth quarter of 2019. It is also higher than the corresponding period last year, which was 16.6%. It should be noted that ELSTAT does not register all the unemployed, due to the "non-formal conditions". Notes that a percentage of the unemployed are registered as "economically inactive", as due to the pandemic, several jobseekers stated that they are not immediately available to work and therefore, according to the definitions of the relevant European Regulation, are classified as economically inactive. It is pointed out that, according to the definition of the unemployed and the economically inactive population, if a person who is not working, is not actively looking for work and is not available to take up work immediately, is not classified as unemployed but in the economically inactive population". If the conditions were "typical", the unemployment rate, both in Epirus and nationwide, could be even higher. Also, the unemployment rate of women is higher than that of men, following the corresponding trend at the national level and the percentage of "young unemployed", ie those who enter the labor market for the first time in search of employment shows an increase.



Regarding the Municipality of Igoumenitsa, the trends in the labour market that are recorded, do not differ significantly from those that prevail and are recorded at the regional level. However, it should be noted that the estimates for the levels of employment and unemployment (in the Region but also in our Municipality) underestimate the real unemployment rate. The problem is particularly acute among the "young unemployed", ie those entering the labour market for the first time in search of employment and the forecasts for the next period, mainly due to the health crisis, are particularly ominous.

1.2. Presentation of the Intervention Area and Key Challenges

1.2.1. The Intervention Area

The Pilot Area is composed of both publicly and privately-owned spaces, so that until they are transformed into area with special destinations and permanent activities, Thriving Streets project is the perfect opportunity to turn them into temporary spaces, providing a benefit to the local community. The area is characterized by reduced accessibility due to issues such as:

- Proximity to city center (4km 7 minutes by car and 30 minutes by walking), and absence of public transit.
- Limited economic opportunities due to lack of investments and development initiatives.
- Vacant and underused outdoor public spaces and abandoned private spaces.



The Pilot Area could be characterized basically as a residential area where the ground floors of the apartment buildings have shops of local scope that today are basically empty and unused. The area tends to be neglected by people who use the urban space, since their commuting is limited only to the absolutely necessary, e.g. to come or leave the place of their residence or the place of work or school. There is no interest in staying or using the common public space outside the buildings. The use of Public Transport and other mild forms of commuting is non-existing, as the use of the private cars has prevailed in all the mobility needs of a household. This fact, over time, drove the commercial and economic interest to the city centre, and out of town where department stores and malls are located, and city neighbourhoods have been abandoned.



In addition, very close to the intervention area there are:

- outdoor sports facilities,
- the suburban forest (grove) and
- the Archaeological Museum.

Since the access to these places is almost exclusively by car, the intervention area does not benefit at all from visitors.

1.2.2.Summary of key challenges

After the initial desk analysis, the discussion with the people in previous consultations, the workshops that took place within the URBACT Local Group (ULG), during engagement activities and one-to-one meetings with stakeholders and residents, we have summarised the main challenges and problems in the area. These can be summarised to the need of increase the area's accessibility and to become attractive for the locals and the tourists.

The area is characterised of reduced accessibility due to issues such as:

- Proximity to city centre (4km 7 minutes by car and 30 minutes by walking)
- Absence of public transit
- Limited economic opportunities due to lack of investments and development initiatives
- Vacant and underused outdoor public spaces and abandoned private spaces.


During the action of process, the most important problems of the intervention area proved to be the following:

Businesses are under-operating


Lack of initiatives for business development

1.3. Focus and Vision

1.3.1. Focus of the Action Plan

The Pilot's Area **Integrated Action Plan IAP** is in-line and directly connected with the broader **Sustainable Urban Mobility Plan - SUMP** of Igoumenitsa Municipality since these two strategic documents are similar and the challenges they try to address are common.

"The urban landscape is defined as 'a space that is appropriated, codified, that has undergone uses, habits, arrangements, that is not above all free and in no case empty'. It is the result of relationships between economic activities, social structures, cultural values, and the natural background that changes over time. It is a dynamic space with the human perpetrator and the affected, not the spectator, the creator, socially and less directly individually. The urban landscape is in this sense, a mirror of the evolution of the city, the form and transformation of its space".



The City of Igoumenitsa focuses on the creation of a well-organized bicycle network, paths for pedestrians and cyclists, on the creation of safety measures for urban cycling, and on the increase of spaces for physical exercise and infrastructures for vulnerable users. Moreover, will focus on the promotion of the cultural heritage of the area connecting the forest paths and the Cyclope's Cave with the Archaeological Museum which is very close to the area and with the Open Cinema events through the year (especially from May to September) in order to enhance the thematic tourism in the area, as a boost to the local economy in relation with the creation of an Open Market Area for local retails.

The neighbourhood approach will develop tailored policies for sustainable mobility in urban areas, at neighbourhood level, using the URBACT Action Planning methodologies to proactively support the liveability of our City. Together with local stakeholders the city of Igoumenitsa will try to develop a step-by-step intervetion plan for the implementation area which complies, and it is a part of **SUMP**. Both Thriving Streets IAP and SUMP, focuses on integrated activities that will upgrade and promote the city mobility, enhance tourism development, and valorise and exploit the cultural and natural capital, protect the environmental, and promote local economy.

The local aim of the **IAP** is to upgrade the quality and traditional character of the area, in order to attract local and foreign visitors and to develop commercial and creative businesses. A green space or a set of such spaces in this area can undoubtedly attract a large number of young residents and tourists by organizing sports and cultural activities. As a result, actions like these strengthen also the encouragement of entrepreneurship (creation of trade uses around the urban greenery).

The greener cities attract more visitors, bring with them retail and leisure expenses, and offer employment and rental opportunities.

1.3.2. Vision

As mentioned above, the **Integrated Action Plan** and the **Sustainable Urban Mobility Plan (SUMP)** of Igoumenitsa Municipality shares the same **vision**, **goals** and **objectives**. What the City Administration and the Project Team intended to achieve, was to prioritise and adjust the goals and the objectives of the Sustainable Urban Mobility Plan (SUMP) to the pilot area, connecting the challenges that have been identified in the Pilot Area, with the URBACT methodology, the participatory procedures and the lesson learned during the project implementation from other city partners.

SUMP is a strategic plan designed to satisfy the mobility needs of people and businesses in the city and its surroundings for a better quality of life. It builds on existing planning practices and takes due consideration of integration, participation, and evaluation principles.

SUMP aims to create an urban transport system by addressing – as a minimum – the following objectives:

- Ensure all citizens are offered transport options that enable access to key destinations and services.
- Improve safety and security.
- Reduce air and noise pollution, greenhouse gas emissions and energy consumption.
- Improve the efficiency and cost-effectiveness of the transportation of persons and goods.
- Contribute to enhancing the attractiveness and quality of the urban environment and urban design for the benefits of citizens, the economy and society as a whole.

Igoumenitsa's SUMP, derived from the basic need of a small city that besides the citizens' daily mobility needs, must also serve thousands of visitors' trips disembarked in its port which connects the inland national area with Ionian Islands and the rest Europe. Igoumenitsa's SUMP, with a 20-year horizon, provides a long-term vision and a clear implementation plan.


The **Thriving Streets Integrated Action Plan**, just like the City's SUMP, considers residents, visitors, and entrepreneurs as part of the solution for addressing the challenges of the Pilot Area, and it is tailored to people's needs and not a bureaucratic and impersonal city operation framework. IAP takes into account the principles of



integration, participation, and continuous evaluation-monitoring-feedback cycle, meets real needs by providing a long-term vision and a clear step by-step implementation plan. Together with local stakeholders the city of Igoumenitsa will try to develop a step-by-step a transformation plan for the implementation area which focuses on integrated interventions and commonly designed and agreed activities aiming at the use of the culture and nature reserve, environmental protection, and the promotion of the local economy by taking using the potential of the cultural and natural capital. In the city of Igoumenitsa there are bike lanes that promote gentle forms of transportation and significantly improve the quality of life. As alternatives to urban regeneration and aesthetic upgrades, they serve the logic of reducing space for cars and increasing space for humans.

The Municipality of Igoumenitsa, faithful to the principles of Sustainable Urban Mobility, envisions to create a thriving neighbourhood, full of economic life and cultural activities, with well-organized bicycle network and pedestrian paths, where residents and visitors can enjoy the public space.





1.4. Description of the Planning Process

1.4.1. Presentation of the ULG

A multi-stakeholder group brought together all relevant local people and organisations, interested in or related to a chosen policy challenge. These stakeholders were engaged to collaborate and to participate in the design, development and implementation of local urban policies representing a variety of voices. A multi-stakeholder group set up with members involved in the process right from the beginning of a project implementation. The project team intended to build a competent ULG having a different mix of local stakeholders involved in the group, inviting representatives from:

- different departments within the local administration,
- elected people responsible for the different policy areas connected to the challenge being addressed,
- beneficiaries of the policies
- third sector, NGOs, social enterprises,
- different tiers of government in the relevant policy area (neighborhood, city),
- the private sector,
- business community.

The development and validation of each step is then a collective undertaking, designed to strengthen partner commitment and to increase the prospect of sustainable delivery. ULG will use the URBACT framework and methods to design integrated urban policies and strategies and to strengthen the capacity of local stakeholders to develop and manage the delivery of efficient policies.

1.4.2. The stages of the dialogue with the ULG

Due to the pandemic of Covid-19 we weren't allowed to organize any open meeting with the Stakeholders apart from virtual online meetings. In February 2020, during the meeting of another project in URBACT, we discussed with the Stakeholders the idea, the scope and the goals of Thriving Streets Project. They all accepted to participate also in this project and to give us their feedback for the actions we want to implement.

Later on, due to the Covid situation we discussed with one-to-one stakeholders via Skype meetings about their ideas, concerning the revitalization of the "Thriving Streets Area" in Igoumenitsa. We received a feedback from mostly all of them and the Small Scale Actions Plan was developed. In the beginning we presented to them the current situation of the area and discussed of the key challenges we can count on to achieve the best result.



During the second week of February 2022, the Project Team organized an on-the-spot meeting with the Stakeholders and residents. In this meeting the actions proposed presented to the Stakeholders, as well as the actions that could be implemented with low cost and would have a result in the frame of the project, according to their comments and suggestions during the online and one-to-one virtual meetings. In this meeting the Small-Scale Actions presented and with their assistance and their volunteering work, we were able to implement some interventions on the sidewalks, on the road, on public spaces so to optimize the urban environment and make safer the access to the schools for the students.



In the next stage, after the completion of the cooperation contract with an external Local Expert to support the Project team to the organization and coordination of URBACT Local Group, five face-to-face meetings with the members of ULG were organized.

The meetings took place during July and were both Thematic with the participation of specific organizations depending on the content of the discussion, as well as General ones for the best possible cooperation between the ULG members and with the Project team. During the live meetings, URBACT program tools and methodologies were used, to activate the participants, to promote cooperation and to co-create and co-design the actions of the IAP. The tools mostly used were the Problem Tree Canva and the Problem and Solution Table, as well as brainstorming and collaboration techniques. During the last meeting, a draft of the Final Phase of the Integrated Action Plan was presented by the project team and the Local expert to the ULG members, so they have an overall picture of the actions included, of the Specific Objectives in which these actions are planned, as well as of the measures and actions that the Municipality of Igoumenitsa will take for their implementation, both until the end of the project and after the end of eligibility period.




It should be noted that throughout the meetings, the main concern of the project team and the local expert was not only to extract ideas and suggestions from ULG members, but also how they will be integrated into the Pilot Area, so that these suggestions respond precisely to the needs and peculiarities and particularities that the area has and how they address the challenges and problems identified. In addition, one of the primary purposes was to ensure the participation of the members

and the organisation of the ULG in the next implementation phase, so to ensure the viability of the actions after the end of the Thriving Streets project eligibility period.



Some of the activities that were discussed during the live meetings, will be included in the Communication and Publicity context of the project during September 2022, and will be integrated into the activities and events that the Municipality of Igoumenitsa traditionally organizes during the European Mobility Week. The active participation of the school community of the city but especially of the pilot area is foreseen, the residents and users of the intervention area expected to play a vital role, but also Civil Society Organizations from the city will present their activities in the target area.



A website of the project was created, linked to the main website of the City of Igoumenitsa, where we are going to upload all the videos form other Cities and Partners presented during the webinars from the beginning of the Project. This will help our Stakeholders to have a clearer idea about the actions we are going to implement and their impact to our citizens quality of life and the revitalization of the area.



1.4.3. Transnational activities and inspirations from partner cities

The experiences exchanged between the cities, and the training seminars held during the project, enabled the Municipality of Igoumenitsa to acquire important knowledge in the field of participatory planning, management of Local Support Group, Coordination and co-decision with stakeholders, and how to adapt the good practices presented to its own intervention area and to promote economic development. The municipality has gained insight into the experiences and practices of other cities, which has contributed significantly to a better understanding of the problems of the intervention area.

1.4.4. Small scale actions

Since it was impossible for us due to Covid 19 to set up our small-scale actions as we had planned, in the frame of European Mobility Week 2020 we created a "Parklet" in front of the entrance of the elementary school in the intervention area.



Unfortunately, from the first day, we did not have the acceptance of it either from the parents of students or the teachers of the school and the citizens and we removed it. Probably it failed due to the lack of communication of our actions to the public or the denial of some people to accept something new.

There were also various issues of a legal nature in relation to the installation of the Parklet in the specific area, issues related to its location, slight obstruction of the movement of cars and pedestrians.

As a result, the installation was removed from the area and the evaluation of its short operation was taken into consideration for the planning of the actions that were finally included in the Integrated Action Plan.

2. Action Plan

The Action Plan is the result of an integrated, co-production journey that the project team conducted with the active participation of the URBACT Local Group members. They were involved in this process right from the beginning and the final document is the coherent expression of a plurality of voices. The co-production is the best guarantee for an integrated approach and increases the chances of successful implementation. 3. Implementation Framework

3.1. Framework for the delivery of the IAP

Up to now, throughout the implementation of the project, the integrated action plan has been organized, coordinated, elaborated, and partially implemented by an interdisciplinary Working Team set up within the Municipality of Igoumenitsa. The Working Team consists of specialized executives from various departments, directorates, and Municipal services, coordinated by a Project Manager coming from the Independent Municipal Department of European projects. Executives from the planning department, the finance department and the relevant technical services also participated. After addressing and overcoming some administrative delays at a Ministry level, the project team also proceeded to external assistance from a technical consultant, specialized in Project Management, EU projects implementation, stakeholder management, and planning.

Important and essential for the finalization of the current Action Plan, was the assistance and active participation of the URBACT Local Group, which together with the project team, configured, measured and adapted the activities proposed in the Action Plan according to the real needs of the pilot area and with the knowledge they have as the main users of the neighborhood. By that, the Work Team followed a bottom-up approach methodology, based on co-decision and the co-creation of the Action Plan

For the following period, during which the implementation of the actions and interventions agreed in this Integrated Action Plan is foreseen, the main responsibility for the implementation lies with the responsible Departments and the City Officials and Policy-Makers on the part of the Municipality. When needed, the actions and the interventions that will take place, will be included in the operational and strategic documents and strategies of the Municipality, and the officials will follow the legal procedures for municipal decision-making process, and for the allocation of the budget required.

3.2. Resourcing and Funding

Concerning the financial resources needed for the implementation of the actions foreseen, this will be achieved either from the regular Municipal Budget, or by using various financial means from Ministries and Regions under the National Strategic Reference Framework (NSRF), as well as other state funding instruments and schemes that finance medium and large-scale projects.

It is also planned to use funding from other European Programs and initiatives, since the Municipality has significant experience and a dedicated department for finding and implementing relevant projects. EU Financial Programs from which additional use of resources may be possible, are expected to be the following:

There are also resources from private initiative through sponsorships, donations, funding in the context of social corporate responsibility of large companies, as well as financing in kind.

At the same time, the contribution from cultural institutions, NGOs and other Civil Society Organisations that are active in the area and in the wider territory, as well as the residents and the school community, who are expected to contribute to the implementation of certain soft actions that do not necessarily have financial nature, but they are necessary for the integrated implementation of the action plan and the promotion of the area, according to the objectives and long-term objectives of the action plan and the municipality of Igoumenitsa.
